

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to bekelectriccompany.com, and Beck Electric Company and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Beck Electric Company include bekelectriccompany.com. the Beck Electric Company website is a news and information site. By using the Beck Electric Company website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Beck Electric Company may collect personally identifiable information, such as your:

- First and last name
- Mailing Address
- E-mail Address
- Phone Number
- Employer
- Job Title

Beck Electric Company may also collect anonymous demographic information, which is not unique to you, such as your:

- Age
- Gender

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

Beck Electric Company collects and uses your personal information to operate and deliver the services you have requested.

Beck Electric Company may also use your personally identifiable information to inform you of other products or services available from Beck Electric Company and its affiliates.

Sharing Information with Third Parties

Beck Electric Company does not sell, rent, or lease its customer lists to third parties.

Beck Electric Company may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to this third party. Beck Electric Company may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. Automatically Collected Information

Use of Cookies
